

**Kibbles ‘n Bits™ Grill Night, Done Right SweepSteaks
Official Rules**

BY PARTICIPATING IN THE SWEEPSTAKES, YOU AGREE TO ABIDE BY AND BE BOUND BY THESE OFFICIAL RULES, WHICH ARE A BINDING CONTRACT, SO READ THEM CAREFULLY BEFORE PARTICIPATING. 1. **ELIGIBILITY:** The Kibbles ‘n Bits™ Grill Night, Done Right SweepSteaks (“Sweepstakes”) is open only to legal residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older as of date of entry. Employees, officers and directors of Post Consumer Brands, LLC (“Sponsor”), Honeymoon Agency, Realtime Media LLC (“Administrator”) and their respective parent companies, affiliates, subsidiaries, or the respective advertising, sweepstakes, fulfillment and marketing agencies of each of the foregoing (collectively, the “Sweepstakes Parties”), and the Premier Parties (as defined below), their immediate family members and those living in the same household as such individuals (whether legally related or not) are not eligible to participate in the Sweepstakes or win a prize. The following file formats are accepted in this Sweepstakes: JPG, PNG, or GIF. Upon successful submission of the entry form and Photo, you will receive one (1) entry into the Sweepstakes, subject to the limit below. Photos submitted are for entertainment purposes only and are not judged. Winners are selected by random drawing as set forth below, and the quality of the Photo has no bearing on an entrant’s ability to win a prize.

Your entry must be suitable for publication and public viewing and must communicate messages consistent with the positive images and goodwill to which the Sponsor wishes to associate. Your entry must not infringe on the rights of any third party and/or contain material that is unlawful, inappropriate, indecent, obscene, hateful, tortious, defamatory, slanderous, libelous, disparaging, and/or discriminatory based on race, gender, religion, nationality, disability, sexual orientation, or age, as determined by Sponsor or Administrator in their sole discretion. 4. **SWEEPSTAKES DRAWING:** On or about May 29, 2026, the Administrator will conduct a random drawing to select five (5) potential winners from among all eligible entries received in accordance with these Official Rules.

6. **WINNER NOTIFICATION/PRIZE CLAIMING:** Each potential winner will be notified via email in a commercially reasonable time after the drawing. The Sweepstakes Parties are not responsible for and shall not be liable for incorrect, changed, or illegible contact information or for electronic communications that are undeliverable as a result of any form of active or passive filtering, or insufficient space in entrant's email or other account to receive messages. DISPUTE RESOLUTION:** The parties each agree to finally settle all disputes only through arbitration; provided, however, the Sponsor shall be entitled to seek injunctive or equitable relief in the state and federal courts in the State of Minnesota, and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury, and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("AAA") or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in the State of Minnesota. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in the State of Minnesota. Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of entrant to attend the arbitration hearing). Either party may, notwithstanding this provision, bring qualifying claims in small claims court.

- 14. Headings are solely for convenience of reference and will not be deemed to affect in any manner the meaning or intent of the documents or any provision hereof.
